APPROVING MAP OF MISSION GARDENS ANNEX SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by NORRIS E. LUEDTKE, Registered Civil Engineer, and entitled, "MISSION GARDENS ANNEX Being a subdivision of portions of Lots 1, 2 and 3 of the subdivision of Lots 61, 62 and the easterly portion of Lot 63 of Rancho Mission, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1550, filed in the office of the County Recorder of San Diego County, March 20, 1913 and Princess View Drive as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage and water facilities, as granted and shown on said map, and subject to the conditions as set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; and that those certain easements with the right of ingress and egress for the

construction and maintenance of drainage and water facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
