WHEREAS, ALGOR PROPERTIES, Owner, and AUTOTRONIC SYSTEMS, INC., "Permittee," filed an application for a conditional use permit to construct and operate a self-service station, located on the north side of Artillery Drive, between State Highway 163 and Linda Vista Road, more particularly described as a portion of Lot 3, Artillery Square Unit 2, in the CN Zone; and

WHEREAS, on February 16, 1972, the Planning Commission of The City of San Diego made its findings of facts, which are set forth in Resolution No. 332-PC, and denied said conditional use permit to Permittee to construct and operate said self-service station; and

WHEREAS, AUTOTRONIC SYSTEMS, INC., by Lawrence Wasserman, attorney, pursuant to the provisions of Section 101.0506 of the San Diego Municipal Code, under date of March 7, 1972, appealed the decision of the Planning Commission; and

WHEREAS, said appeal was set for public hearing on April 4, 1972, testimony having been heard, evidence having been submitted and the City Council having fully considered the matter and being fully advised concerning the same; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

This Council finds and hereby declares that the findings of the Planning Commission set forth in its Resolution No. 332-PC are supported in all particulars by the testimony, minutes, tape of the proceedings, maps and exhibits, all of which are herein incorporated by reference, and said findings are hereby adopted as the findings of this Council.

BE IT FURTHER RESOLVED, that by a vote of 9 to 0, the appeal of AUTOTRONIC SYSTEMS, INC., by Lawrence Wasserman, attorney, be, and it is hereby denied; and the decision of the Planning Commission denying Conditional Use Permit No. 332-PC to construct and operate said self-service station be, and it is hereby upheld.
