

**RESOLUTION No. 205293**


Adopted on APR 6 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized to accept the proposal of the Center for Public Economics of San Diego State College to study the impact of transferring Metropolitan Water District and San Diego County Water Authority taxes from water revenues to the property tax in the manner and for the compensation set forth in that letter dated January 10, 1972, from San Diego State College, a copy of which is on file in the office of the City Clerk as Document No. 739655.

BE IT FURTHER RESOLVED, that the City Auditor is authorized to transfer \$25,000 within the Water Operating Fund 500 Reserve (67.49-3495) to Professional Services (67.27-3295) solely and exclusively for the above mentioned purpose.
