

RESOLUTION NO. 205300 APR 6 1972

WHEREAS, the City Council of The City of San Diego, on October 14, 1971, by Resolution No. 203960, authorized submission to the Economic Development Administration of an application for financial assistance under the Accelerated Public Works Program; and

WHEREAS, on March 21, 1972, the Economic Development Administration notified The City of San Diego of formal grant offer not to exceed \$600,000, pursuant to the application; and

WHEREAS, the proposed project includes replacement of all deteriorated, broken and missing sidewalks, curbs and gutters, and construction on a need basis of new sidewalks in Southeast San Diego and San Ysidro; and

WHEREAS, the total project cost is \$750,000, \$600,00 of which is Federal participation and \$150,000 of which is the local share from Model Cities supplemental funds; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a contract with the United States Department of Commerce, Economic Development Administration, a form of which is

on file in the office of the City Clerk as Document
No. 739585, accepting a grant offer not to exceed
\$600,000 for sidewalk, curb and gutter improvements in
Southeast San Diego and San Ysidro.
