BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Toro Pacific Distributing 2. Pacific Products Inc. 3. Contractor Supply are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of LAWN SPRINKLERS AND PARTS as may be required for a period of one year beginning May 1, 1972 through April 30, 1973 per prices on file in the Purchasing Department, with option to renew the contracts for an additional one year period as follows:

1. Toro Pacific Distributing for Group I - Toro Sprinklers and Parts from list prices; terms 2% 30 days, plus sales tax, prices firm.
2. Pacific Products Inc. for Group II - Rainbird Sprinklers and Parts from list prices; terms net 30 days, plus sales tax, subject to escalation not to exceed 10% of bid prices.
3. Contractor Supply for Group III - Buckner Sprinklers and Parts from list prices; terms 2% 30 days, plus sales tax, subject to escalation not to exceed 10% of bid prices.
