A. General Electric Company for Item 1 with option 3, Item 3 with option 1, Item 7, no options, for a total cost of \$7,936.00; terms net, 30 days, plus sales tax; with an option to buy additional equipment within one year of date of initial purchase order, and;

B. Motorola Communications and Electronics, Inc. for Item 4, with options 4, 5 and 6, Item 5 with option 1, for a total cost of \$4,787.00; terms net, 30 days, plus sales tax; with option to buy additional equipment within one year of date of initial purchase order.

2. That all bids heretofore received on March 1, 1972 pursuant to publication of notice calling for bids for Item 2, FIXED AND PORTABLE RADIO EQUIPMENT are hereby rejected.
