APPROVING MAP OF LA JOLLA SOLEDAD WEST UNIT NO. 1 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled "LA JOLLA SOLEDAD WEST UNIT NO. 1 Being a subdivision of portions of Pueblo Lots 1263 and 1264 of the Pueblo Lands of San Diego in The City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of said Map was filed in the County Recorder's Office November 14, 1921 and is known as Miscellaneous Map No. 36.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets, to wit: Via Valverde and Via Estrada for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to those portions of Lots 84-A and 104-A marked "Reserved For Future Street" adjacent and

contiguous to Lot 84-A open space area and Lot 82-A, all as shown on this map within this subdivision; together with the easements with the right of ingress and egress for the construction and maintenance of water facilities as granted on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, those easements listed in the certificate signed by the Owners for: general utility and access purposes, and open space; as granted and shown on said map and subject to the conditions expressed therein.


BE IT FURTHER RESOLVED, that said Council rejects as a dedication for public street those portions of Lots 84-A and 104-A marked "Reserved for Future Street" as shown on this map, under the provisions of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; that those certain easements with the right of ingress and egress for the construction and maintenance of water facilities, together with certain abutters' rights of access and those easements listed in the certificate signed by the Owners are accepted on behalf of The City of San Diego, a municipal corporation, as above stated;

and said Council has rejected those portions of Lots 84-A and 104-A marked "Reserved for Future Street" shown on this map within this subdivision, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
