

RESOLUTION NO. 205326 APR 11 1972

WHEREAS, a private road easement was acquired by The City of San Diego at no cost to the public by deed filed in the Office of the City Clerk as Document No. 617236 and recorded in the Office of the San Diego County Recorder on December 8, 1960, as File/Page No. 238885 of Official Records; and

WHEREAS, said private road easement was required to provide access for the operation and maintenance of a sewage pump station in Carroll Canyon; and

WHEREAS, access for the operation and maintenance of said sewage pump station in Carroll Canyon is now provided by public streets of recent subdivision developments; and

WHEREAS, due to the access now provided by said public streets, the City no longer needs said private road easement; and

WHEREAS, Thirty-five Dollars (\$35.00) has been collected from the applicant by The City of San Diego Property Department as consideration; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Mayor and the City Clerk of The City of San Diego be and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of The City of San Diego, a quitclaim deed, the form of

which is on file in the office of the City Clerk as Document No. 739630, quitclaiming to the OWNERS IN FEE SIMPLE OF RECORD, all of said City's interest in a portion of Section 1, Township 15 South, Range 3 West, San Bernardino Base and Meridian, as more particularly described in said form of quitclaim deed.

2. That the City Clerk is hereby authorized and directed to deliver said Quitclaim Deed, together with a certified copy of this resolution to the Property Director of said City for further handling.
