A RESOLUTION CREATING A LOS PENASQUITOS REGIONAL PARK JOINT CITY-COUNTY CITIZENS ADVISORY COMMITTEE.

WHEREAS, The City of San Diego has been requested by the County of San Diego to participate in the formation of a seven-member Citizens Advisory Committee for Los Penasquitos Regional Park, four members to be appointed by the Mayor and confirmed by Council and three members to be appointed by the Board of Supervisors; and

WHEREAS, the City Council has studied the desirability of establishing the park from the position of preserving and protecting the environmental and ecological value of the area as well as providing both natural and recreational park areas; and

WHEREAS, at a Council conference conducted January 11, 1972, it was determined to proceed as rapidly as possible to develop ways and means to assist the County in acquiring thirty-four hundred (3,400) acres or more of canyon land for park purposes as recommended in the Linesch & Reynolds Land Acquisition Report for Los Penasquitos Regional Park; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

- 1. A Los Penasquitos Regional Park Joint City-County
 Advisory Committee, herein called "Committee," is hereby
 created. The Committee shall be composed of seven persons,
 four of whom shall represent the City of San Diego and three
 of whom shall represent the County of San Diego.
 - 2. Appointments shall be made in the following manner:
 - a. The Mayor shall appoint and the Council shall confirm the four City members.
 - b. The three County members shall be chosen by County through County procedures.
- 3. The function and responsibility of the Committee shall be to proceed immediately into a study of ways and means to assist the County in acquiring a minimum of thirty-four hundred (3,400) acres, and to submit its report with recommendations as soon as possible to the City and the County.
- 4. The Committee shall automatically dissolve upon submission and acceptance of its report and recommendations on the ways and means of acquiring said acreage unless the City Council and the County Board of Supervisors, by specific direction, shall cause it to continue.
- 5. The following named persons appointed by the Mayor are hereby confirmed.

 - d. Lou Wolfsheimer
