That the City Manager be and he is hereby fully authorized and empowered to execute, on behalf of The City of San Diego, an agreement with MICHAEL BABUNAKIS for consultant services for a one-year period beginning April 17, 1972, pursuant to the terms and conditions of the form of agreement on file in the office of the City Clerk as Document No. 739637.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of twenty-three thousand dollars (\$23,000) within the 100 Fund from Unallocated Reserve (53.30) to Allocated Reserve (53.20) solely and exclusively for the purpose of providing remuneration for consultant services of Michael Babunakis.
