That the expenditure of One Hundred Sixty-five Thousand Dollars (\$165,000) is hereby authorized from Gas Tax Funds solely and exclusively to cover the cost of acquisition services for 47th Street widening between Imperial and Ocean View Avenues, under the terms and conditions of the Cooperative Agreement between THE CITY OF SAN DIEGO and the STATE OF CALIFORNIA, DIVISION OF HIGHWAYS, on file in the office of the City Clerk as Document No. 739642, and related expenses.
