

RESOLUTION NO. 205341 APR 11 1972

WHEREAS, the Council of The City of San Diego, by Resolution No. 204843 dated February 8, 1972, adopted a program of Affirmative Action in municipal employment for minorities; and

WHEREAS, the Council directed the City Manager and Personnel Director to review the program for purposes of incorporating therein Affirmative Action provisions for women; and

WHEREAS, the Council in conference on March 7, 1972, directed that the Affirmative Action Program for municipal employment be amended to include women, said amended program to be brought forth for Council consideration at the earliest possible date; NOW, THEREFORE,

BE IT RESOLVED, that the Affirmative Action Program of The City of San Diego for municipal employment be and the same is hereby amended to incorporate therein employment and promotional opportunities for women in accordance with the provisions of the ~~form~~^{35.} of program on file in the office of the City Clerk as Document No. 739643.

BE IT FURTHER RESOLVED, that the City Manager and Personnel Director be and they are hereby directed to implement said program and establish necessary rules and regulations in support and execution thereof.
