

RESOLUTION NO. 205343 APR 11 1972

WHEREAS, The City of San Diego and the County of San Diego entered into an agreement dated January 28, 1969, on file in the office of the City Clerk as Document No. 727323, whereby in conjunction with a 1911 Improvement Act proceeding the City and County agreed to share in a portion of the costs and expenses for the improvement of a certain portion of Imperial Avenue between 40th Street and 46th Street for which no property owner is being assessed; and

WHEREAS, pursuant to said agreement and in conjunction with said Improvement Act proceedings, the City entered into a contract for said improvement with R. E. Hazard Contracting Co.; and

WHEREAS, there are now certain changes and modifications necessary and convenient to be made in the work proposed to be done and mutually agreed upon by the City, County and contractor; and

WHEREAS, the Streets and Highways Code, Sections 5126 and 5236, provides procedures whereby a city may contribute to street improvement projects for the cost and expenses of said work and to changes thereof when so requested and financed by said City; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of The City of San Diego, as follows:

That Change Order No. 1, dated March 7, 1972, heretofore filed with the City Clerk of said City as Document No. 739644, ~~issued~~ in connection with *RSC* the contract between The City of San Diego and R. E. Hazard Contracting Co. for the widening of Imperial Avenue between 40th Street and 46th Street and other associated street work, amounting to an increase in the contract price of \$8,569.55, be and the same is hereby approved.

BE IT FURTHER RESOLVED, that an increase of \$8,569.55 in City's contribution is hereby authorized from Gas Tax Fund 219, solely and exclusively for said Change Order, and supplementing Resolution No. 203038 in said amount. Said amount shall be payable one-half by the City and one-half by the County pursuant to the agreement on file in the office of the City Clerk as Document No. 727323. None of the cost and expense resulting from said Change Order shall be assessed to the private property owners within the assessment district described in Resolution No. 202111 dated March 9, 1971.
