BE IT RESOLVED, by the Council of The City of San Diego as follows:

Associated Concrete Products Inc. are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of CONCRETE WATER METER AND UTILITY BOXES as may be required for the period of one year beginning May 1, 1972 through April 30, 1973 per prices on file in the Purchasing Department as follows:

1. Peterson Concrete Inc. for Group I - six items of meter boxes and covers; terms 2% 10 days, plus sales tax with option to renew for an additional year.
2. Associated Concrete Products Inc. for Group II - two items of concrete utility vaults; terms 1% 30 days plus sales tax.
