BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of thirty thousand eight hundred fifty dollars (\$30,850) consisting of fourteen thousand dollars (\$14,000) from Montgomery Field Aviation Fund 240 and sixteen thousand eight hundred fifty dollars (\$16,850) from the Bond Fund 726 --- Resolution No. 193951 to Capital Outlay Fund 245, solely and exclusively for providing sufficient funds for construction, improvements and related work at Montgomery Field.

BE IT FURTHER RESOLVED, that the sum of sixty-seven thousand eight hundred fifty dollars (\$67,850) be and the same is hereby authorized to be expended from Capital Outlay Fund 245 for said construction, improvements and related work at Montgomery Field.
