WHEREAS, The City of San Diego is the owner of certain easements for water purposes affecting portions of Pueblo Lot 276 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, a copy of which is on file in the office of the San Diego County Recorder; and

WHEREAS, the owners of said Lot 276, have requested that the City quitclaim to them its interest in and to said easements; and

WHEREAS, the improvements that were served by those easements have been abandoned and said easements are not needed for any present or prospective City use; and

WHEREAS, the Utilities and Public Works-City Engineer
Departments have no objection to said sale; and

WHEREAS, the City desires to negotiate the sale of said easement to The Owners in Fee Simple of Record, under the provisions of Section 22.0902 (e) of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such an interest in real property as this may be reasonably accomplished only by negotiation; and

WHEREAS, the value of the property rights sought, as determined by a staff appraiser of said City, is the sum of Three Thousand Three Hundred Seventy-Five Dollars

(\$3,375.00); and

WHEREAS, a fee of Thirty-Five Dollars (\$35.00) has been collected to process this request; and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aformentioned property rights is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That those certain real property rights described in that form of quitclaim deed on file in the office of the City Clerk as Document No. 739679, be, and the same are hereby authorized to be sold by negotiation for the sum of \$3,375.00) to THE OWNERS IN FEE SIMPLE OF RECORD.
- 2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 739679, quitclaiming to THE OWNERS IN FEE SIMPLE OF RECORD, easements for water purposes across portions of Pueblo Lot 276 of the Pueblo Lands of San Diego, as more particularly described in said form of quitclaim deed.
- 3. That no broker's commission shall be paid by City on the herein-described negotiated sale.

4. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
