

RESOLUTION NO. 205409 APR 25 1972

WHEREAS, the City Council has in Resolution No. 205253 declared that certain weeds, rubbish, refuse and dirt existing on private property as described in Document No. 739414 on file in the office of the City Clerk constitute a public nuisance; and

WHEREAS, the Council has in said resolution declared its intention to order the abatement of same; and

WHEREAS, the hearings provided for in said resolution and required by law have been held and all objections to the proposed removal of weeds, rubbish, refuse and dirt have been fully heard and considered; and

WHEREAS, the Council has in Resolution No. 205409 disposed of any and all objections made except for those matters described more particularly in Exhibit A, attached hereto and incorporated herein, which were continued for a two weeks' time period, and by allowing the objections of Mr. Carl Patlaf, 1990 Titus Street, San Diego, California, and Mr. Andrew Menas, 5519 Moonlight Lane, La Jolla, California, and overruling and denying all others; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Public Works Director of The City of San Diego, the person previously designated as the Superintendent in this matter, is hereby ordered to abate said nuisance by having the weeds, rubbish, refuse and dirt removed.
