BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of four thousand dollars (\$4,000) within the 100 Fund from Unallocated Reserve (53.30) to Special Consulting Services (43.05) solely and exclusively for the purpose of providing funds for the above consulting services.
