That Change Order No. 1, dated February 15, 1972, heretofore filed with the City Clerk of said City as Document No. 739935, issued in connection with the contract between The City of San Diego and Mitrovich, Inc. for the construction of the "A" Street Interceptor Sewer, said contract having been filed as Document No. 738867, in the office of said City Clerk, be and the same is hereby approved; and the changes therein set forth, being an increase of \$5,500, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$1,540 from Water Utility Bond Fund 502 and of \$3,960 from Sewer Revenue Fund 506, be and they are hereby authorized solely and exclusively for the purpose of providing funds for the contract changes described above.
