


RESOLUTION No. 205460

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$13,360.64 by Vincent Corsi, An Individual dba Corsi Construction Company for the IMPROVEMENTS TO THE COPPER ROOM AND SILVER ROOM OF THE COMMUNITY CONCOURSE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 739367.
2. That the expenditure of \$15,500.00 is hereby authorized out of the Community Concourse Operation Fund (254) of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENTS TO THE COPPER ROOM AND SILVER ROOM OF THE COMMUNITY CONCOURSE in the City of San Diego, and related costs.
