Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 739805, quitclaiming to the OWNERS IN FEE SIMPLE OF RECORD of Lots 106, 112 and 115 of Rancho San Carlos Unit No. 3 according to Map thereof No. 6798 filed in the office of the San Diego County Recorder, existing easements for drainage purposes affecting portions of Lots 106, 112 and 115 Rancho San Carlos Unit No. 3, as more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be and he is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director of said City for further handling.
