

RESOLUTION NO. 205533 MAY 9 1972

WHEREAS, the City Council has in Resolution No. 205253 declared that certain weeds, rubbish, refuse and dirt existing on private property as described in Document No. 739414 on file in the office of the City Clerk constitute a public nuisance; and

WHEREAS, the Council has in said resolution declared its intention to order the abatement of same; and

WHEREAS, the hearings provided for in said resolution for the consideration by the Council of factual showings by affected property owners why said nuisance should not be abated and any and all objections to the proposed removal of weeds, refuse, rubbish and dirt have been held at the times and place fixed therefor; and

WHEREAS, at said hearings all persons desiring to be heard were fully heard and all oral and written objections, if any, were fully considered and this Council gave all persons present an opportunity to hear and be heard in respect to the proposed abatement; and

WHEREAS, in Resolution No. 205409, adopted April 25, 1972 by this Council, all oral and written objections and protests to the said abatement were overruled and denied except for those which were specifically allowed or continued and as more particularly described in the aforesaid resolution; and

WHEREAS, the continued matters were fully considered and heard at a public hearing conducted on May 9, 1972, with all

persons present again given an opportunity to hear and be heard in respect to the proposed abatement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That each and every oral and written protest or objection, if any, made or filed in the matter of the proposed removal of weeds, refuse, rubbish and dirt is hereby overruled and denied except for the following named persons and properties, which are expressly allowed and exempted:
