

RESOLUTION NO. 205534 MAY 9 1972

WHEREAS, the City Council has in Resolution No. 205253 declared that certain weeds, rubbish, refuse and dirt existing on private property as described in Document No. 739414 on file in the office of the City Clerk constitute a public nuisance; and

WHEREAS, the Council in said resolution declared its intention to order the abatement of the same; and

WHEREAS, the hearings provided for in said resolution and required by law have been held and all objections to the proposed removal of weeds, rubbish, refuse and dirt have been fully heard and considered; and

WHEREAS, the Council has in Resolutions Nos. 205409 and 205533 disposed of any and all objections made by allowing and exempting those persons and properties more particularly described in Exhibit A, attached hereto and incorporated herein, consisting of one sheet, and by overruling and denying all others; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Director of Public Works of The City of San Diego, the person previously designated as the Superintendent in this matter, is hereby ordered to abate the said nuisance on all properties described in Document No. 739414 on file in the

office of the City Clerk except for those referred to in Exhibit A, attached hereto and incorporated herein, which were expressly exempted, by having the weeds, rubbish, refuse and dirt removed.
