RESOLUTION APPROVING PLANS AND PROFILES SHOWING THE CONTEMPLATED CHANGES AND MODIFICATIONS IN THE WORK DESCRIBED IN RESOLUTION OF INTENTION NO. 205324 FOR THE IMPROVEMENT OF BURTON STREET AND COOLIDGE STREET BY THE INSTALLATION OF AN ORNAMENTAL STREET LIGHTING SYSTEM AND PLANTING OF TREES; UPTON COURT, COMSTOCK COURT, LEVANT STREET, AND THE EASEMENT ADJACENT TO LOTS 8 AND 9, BLOCK 59, LINDA VISTA UNIT NO. 4, BY THE INSTALLATION OF SIDEWALKS.

WHEREAS, this City Council did on April 11, 1972, adopt Resolution of Intention No. 205324 and declare its intention to order the construction of certain improvements as more fully described therein and on the plans, profiles and drawings therein referred to, and did provide for the cost of certain work to be assessed against the district described in said Resolution of Intention; and

WHEREAS, the public interest, convenience and necessity require that certain changes and modifications be made in the proposed work to be done in said Resolution of Intention and that said Resolution of Intention be amended to delete the ornamental street lighting system and street tree planting on Burton and Coolidge Streets; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the plans, drawings, typical cross-sections, profiles and specifications for the improvement of BURTON STREET AND COOLIDGE STREET, UPTON COURT, COMSTOCK COURT, LEVANT STREET AND THE EASEMENT ADJACENT TO LOTS 8 AND 9, BLOCK 59, LINDA VISTA UNIT NO. 4,

heretofore filed in the office of the City Clerk as Document No. 739596 and approved by Resolution No. 205323, be and the same is hereby amended to conform with Drawing No. 15157-1-D, filed in the office of the City Clerk as Document No. 739905, and the same are hereby approved and adopted as the official drawings, typical cross-sections, profiles and specifications for said work and improvement.
