hereof, be and the same is hereby ordered vacated.

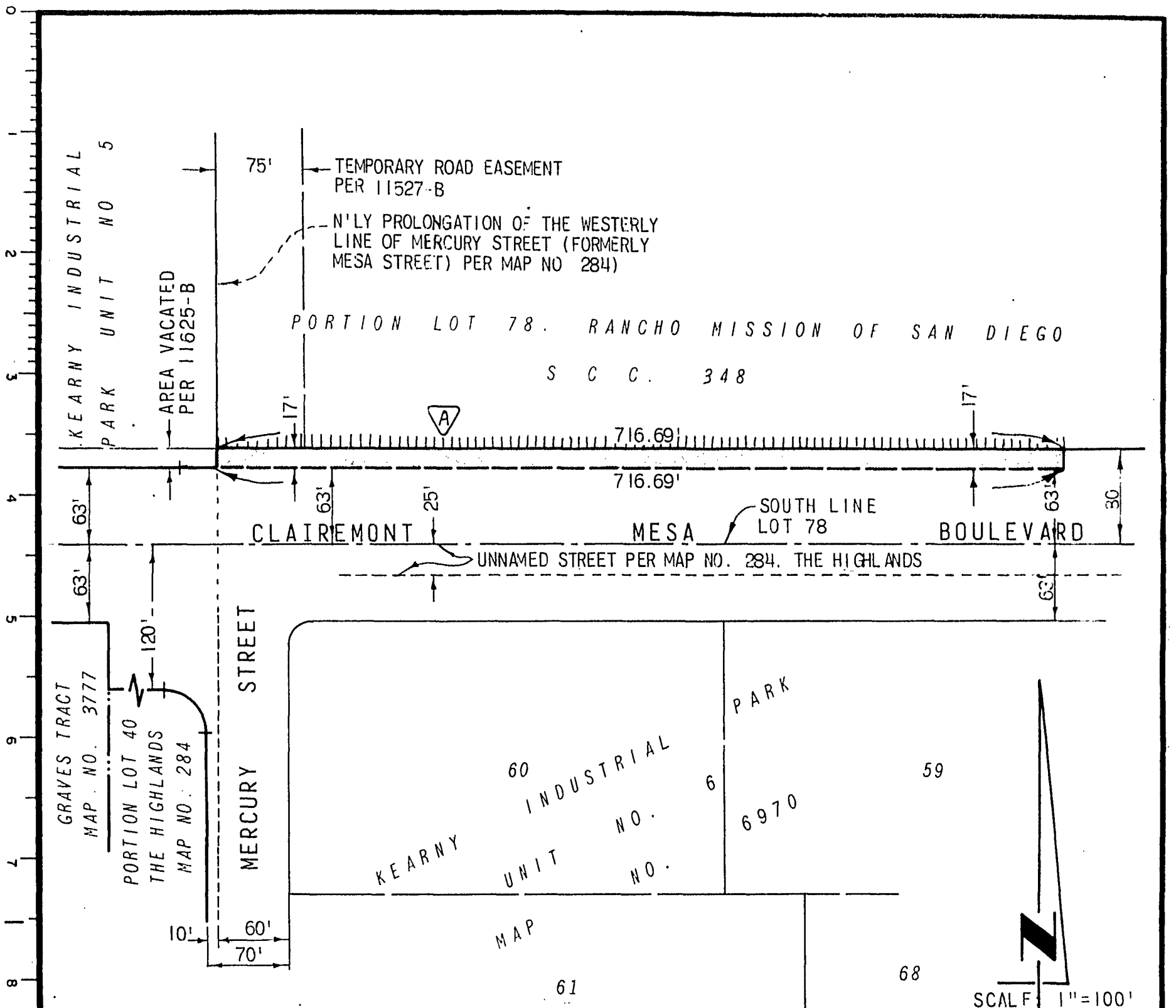
BE IT FURTHER RESOLVED, that the access rights adjacent to
