

RESOLUTION NO. 205542

APPROVING MAP OF SEQUOIA PACIFIC INDUSTRIAL PARK
SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, a Registered Civil Engineer, and entitled "SEQUOIA PACIFIC INDUSTRIAL PARK Being a subdivision of a portion of Lot 78 of the Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California according to Map thereof on file in the office of the County Clerk of said County, in an action entitled 'Juan M. Luco, et al., vs. The Commercial Bank of San Diego, et al.,' in Superior Court Case No.162892, together with the northerly 63.00 feet of Clairemont Mesa Boulevard adjoining said land on the south.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets, to wit: Mercury Street, Mercury Court and Mercury Point, for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on said map, and subject to the conditions as set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
