

RESOLUTION NO. 205545 MAY 10 1972

WHEREAS, the City Council of The City of San Diego on January 25, 1972, adopted Resolution No. 204729 thereby granting a property owner petition for the conversion of existing overhead and communication facilities to underground locations within the public rights of way and on private property, on Calle Del Cielo, adjacent to Lots 29 through 35, La Jolla Del Norte, Map No. 4018, in the City of San Diego, under the combined terms of the 1911 and 1913 Improvement Acts; and

WHEREAS, a second and supplemental property owner petition has been received by The City of San Diego for the conversion of existing overhead and communication facilities to underground locations within the public rights of way and on private property on Calle Del Cielo, adjacent to Lots 26 through 28, La Jolla Del Norte Unit No. 2, Map No. 3469, under the provisions of the 1911 and 1913 Improvement Acts; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Resolution No. 204729, adopted January 25, 1972, be amended by adding the following:

"That the supplemental petition for the construction of certain improvements on Calle Del Cielo, adjacent to Lots 26 through 28, La Jolla Del Norte, Unit No. 2, Map No. 3469, under the provisions of the Improvement Acts

of 1911 and 1913, consisting of one sheet and filed under Document No. 739910, is hereby granted.

"That the City Manager be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the conversion of existing overhead and communication facilities to underground locations within the public rights of way and on private property, on Calle Del Cielo, adjacent to Lots 26 through 28, La Jolla Del Norte Unit No. 2, Map No. 3469, in the City of San Diego, together with the estimates of the costs and expenses of such work and to furnish this Council with a description of the district and a plat showing the exterior boundaries of the district to be included in the assessment for the work and improvements hereinabove mentioned."
