Sandra L. Swartz	POLICE DEPARTMENT	\$300	A change in the City policy in regard to provision of uniforms to employees who require them was proposed. A. R. 35.60 has been revised, and provides that the cost of uniforms will be reimbursed when employees complete probation. The previous arrangement resulted in losses and administrative costs estimated at over \$9,000 a year. This is an initial award. Actual savings will be reviewed in 12 months.
Robert A. Morgan	FIRE DEPARTMENT	\$120	The suggester, an Auto Messenger in the Fire Department, recommended a much less expensive but equally effective cleaning agent to replace one extensively used in all fire stations. A \$1,200 per year saving is expected.
