BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a first amendment to agreement with J. J. J. KENNEDY, Landscape Architect, amending an agreement dated June 3, 1971, on file in the office of the City Clerk as Document No. 736553 for architectural services relating to landscaping of the Mission Bay Interchange and North Torrey Pines Road, under the terms and conditions set forth in the form of first amendment to agreement on file in the office of the City Clerk as Document No. 739921.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to supplement Resolution No. 203044 in Gas Tax Fund 219 in the amount of \$12,500.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to expend the sum of \$26,000 solely and exclusively for the architectural services relating to landscaping described above, said expenditures to consist of \$12,500 from Resolution No. 203044 and \$13,500 from Park and Recreation Bond Fund 725.
