

RESOLUTION NO. 205606

WHEREAS, by easement deed filed December 12, 1956 in Book 6378, Page 497 of Official Records, in the office of the San Diego County Recorder, The City of San Diego acquired an easement for water purposes affecting a portion of College Ranch Unit No. 5-A; and

WHEREAS, the need for said water easement has been eliminated by reason of relocation of a water main to a dedicated portion of Lake Murray Boulevard fronting the affected property; and

WHEREAS, the City has no present or prospective use for said easement and the City Manager has recommended that the City vacate its interest therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of The City of San Diego a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 739961, quitclaiming to THE OWNERS IN FEE SIMPLE OF RECORD of College Ranch Unit No. 5-A, according to Map thereof No. 4459 filed in the office of the San Diego County Recorder, the existing easement for water purposes

affecting a portion of College Ranch Unit No. 5-A, as more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be and he is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director of said City for further handling.
