

RESOLUTION NO. 205612 MAY 16 1972

WHEREAS, the Council of The City of San Diego designated a survey area for the project entitled "Plaza Redevelopment Project" by Resolution No. 204800 on February 1, 1972, pursuant to Section 33310 of the Community Redevelopment Law, Health and Safety Code of the State of California; and

WHEREAS, a preliminary plan was prepared and approved by the Planning Commission of The City of San Diego for the Plaza Redevelopment Project pursuant to Section 33330 of the Health and Safety Code of the State of California by Resolution No. 144 on April 19, 1972; and

WHEREAS, it is now necessary for the Council and the Redevelopment Agency of The City of San Diego to hold a public hearing and adopt a redevelopment plan for the Plaza Redevelopment Project; and

WHEREAS, Section 33355 of the Health and Safety Code of the State of California provides that as an alternative to a separate public hearing, the Council of The City of San Diego may, with the consent of both bodies, hold a joint public hearing on the redevelopment plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Council of The City of San Diego does hereby consent to a joint public hearing as provided for by Sections 33355 through 33359 of the Health and Safety Code of the State of California.

2. That June 20, 1972 is designated as the date for the joint hearing by the Council and the Redevelopment Agency of The City of San Diego, said hearing to be held at 2:00 p.m. in the Council Chambers, 12th Floor, City Administration Building, Community Concourse, San Diego, California.
