Charles F. Reeves	RECREATION	\$250	This is an additional award to the original \$250 award made a year ago. A much improved system for moving large numbers of rowboats from one reservoir to another was developed. This has saved over \$5,000 during the first year it has been in use. It has also provided flexibility for such moves so that revenue from boat rentals is increased by having them available where needed.
Vernon C. Barnett	PROPERTY	\$85	A much improved procedure for obtaining "right of entry permits" needed for sewer replacement projects was developed. A high percentage of such permits are now obtained by mail, saving an estimated \$871 a year in the former personnel costs.
