GIBLIN, Registered Civil Engineer, and entitled "HOLLY HILLS VISTA UNIT NO. 5 Being a subdivision of portions of Lots 6 through 22 of Block K, Narragansett Heights, in The City of San Diego, County of San Diego, State of California, according to Map thereof No. 1041, filed in the office of the County Recorder of San Diego County, April 5, 1907.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets and portion of street, to wit: Braun Avenue, San Felipe Street, Worthington Street, and a portion of Innsdale Avenue for public purposes and said streets and portion of street are hereby declared to be public streets and portion of public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication for public street those portions of Lots 153 and 154 marked "Reserved for Future Street" as shown on this map, under the provisions of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of public street are hereby accepted on behalf of the public as heretofore stated; that that certain easement with the right of ingress and egress for the construction and maintenance of drainage facilities, together with certain abutters' rights of access are accepted on behalf of The City of

San Diego, a municipal corporation, as above stated; and said Council has rejected those portions of Lots 153 and 154 marked "Reserved for Future Street" shown on this map within this subdivision, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
