

RESOLUTION No. 205653

Adopted on MAY 23 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of GAIL M. SHEETS, executed in favor of The City of San Diego, bearing date of April 10, 1972, conveying to said City an easement and right of way for street purposes through, over and across a portion of Lot 135 of Empire Addition to Encanto Heights, according to the Map thereof No. 1254, filed April 26, 1910 in the office of the San Diego County Recorder, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named REPUBLIC STREET.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
