Gussa, Inc., for the construction of the Fine Arts Gallery Sculpture Garden and Building Air Conditioning and Humidity Controls, said contract having been filed as Document No. 739357 in the office of said City Clerk, be and the same are hereby approved; and the changes therein set forth, amounting to an increase in the contract price of \$10,335, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$10,335 is hereby authorized from Capital Outlay Fund 245 solely and exclusively for the purpose of providing funds for the changes described in Change Orders Nos. 1 and 2.
