

RESOLUTION NO. 205667 MAY 23 1972

WHEREAS, the Fine Arts Society of San Diego has generously offered to contribute to The City of San Diego the sum of \$10,335.67 for the purpose of providing funds for changes in the construction contract for the Fine Arts Gallery Sculpture Garden and Building Air Conditioning and Humidity Controls; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager of The City of San Diego hereby accepts the generous contribution of \$10,335.67 from the Fine Arts Society of San Diego and directs that said contribution be deposited in Capital Outlay Fund 245 to be used exclusively for the purpose of providing funds for the work described in Change Orders Nos. 1 and 2 of the contract between The City of San Diego and Art A. Gussa, Inc. for the construction of the Fine Arts Gallery Sculpture Garden and Building Air Conditioning and Humidity Controls.

2. That this Council does hereby commend the Fine Arts Society of San Diego for this act of civic generosity and does hereby publicly express on behalf of the citizens of this City a debt of gratitude to the Fine Arts Society of San Diego.
