Adopted on MAY 23 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the transfer of \$12,753 from the Public Transportation Reserve Fund 2571 to Grant Fund 2573, to cover additional cost incurred in the purchase of forty (40) new City transit buses be, and the same is hereby authorized.

BE IT FURTHER RESOLVED, that the temporary loan transfer of \$18,000 from Public Transportation Reserve Fund 2571 to Grant Fund 2573 to cover project cost reimbursement from the sale of used transit buses be, and the same is hereby authorized. Public Transportation Reserve Fund 2571 shall be reimbursed to the extent of total proceeds received from the sale of those used buses which are to be replaced through the above purchase.
