BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, Agreement No. 14-30-3068 with the United States Department of the Interior, Office of Saline Water, whereby the City will participate in a study of a large-scale desalting plant in the San Diego area and will pay a share of the cost of said study not to exceed \$32,890, under the terms and conditions set forth in the form of Agreement No. 14-30-3068, on file in the office of the City Clerk as Document No. 740033.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$32,890 within the Water Operating Fund 500 from Unallocated Reserve (67.49-3495) to Research Activity (63.86-3299) solely and exclusively for the above purpose.
