


RESOLUTION No. 205690

BE IT RESOLVED, by the Council of The City of San Diego as follows:

The City Manager is hereby authorized and empowered to execute, for and on behalf of City, an agreement with AVCO COMMUNITY DEVELOPERS, INC., a California corporation, for the construction of improvements on West Bernardo Drive and Duenda Road, within the limits of WEST BERNARDO VILLAGE UNIT NO. 3, WESTWOOD UNIT NO. 6, and WESTWOOD UNIT NO. 8 subdivisions, and to provide for reimbursement by the City out of Gas Tax Funds, in an amount not to exceed \$6,883.58, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 740071.
