

RESOLUTION No. 205694

Adopted on MAY 30 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of BALGRAVE CORPORATION, a Delaware corporation, executed in favor of The City of San Diego, bearing date of April 10, 1972, conveying to said City an easement and right of way for street purposes through, over and across a portion of Lot 10 of Balboa Towers Unit No. 1, Map No. 5638, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named GENESEE COURT EAST.

BE IT FURTHER RESOLVED, that the acceptance by the City Manager of that deed of GENESEE PARK APARTMENTS, a limited partnership, executed in favor of The City of San Diego, bearing date of April 7, 1972, conveying to said City an easement and right of way for street purposes through, over and across a portion of Lot 10 of Balboa Towers Unit No. 1, Map No. 5638, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named GENESEE COURT EAST.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deeds to the Property Department for recording and further disposition.
