That the expenditure of \$72,500.00 is hereby authorized out of the Gas Tax Fund (220) of the City of San Diego solely and exclusively for the purpose of providing funds for the WIDENING OF RANCHO BERNARDO ROAD BETWEEN BERNARDO CENTER DRIVE AND BERNARDO OAKS DRIVE, in the City of San Diego, and related costs.
