

RESOLUTION NO. 205725

APPROVING MAP OF TIME SHOPPING CENTER SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled "TIME SHOPPING CENTER Being a subdivision of a portion of Lot E of partition of a portion of Lot 70, Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to Referee's Partition Map thereof made in an action entitled 'San Diego Realty Company, a corporation, vs. Maria Y. Olvera De Toro, et al.', on file in the office of the County Clerk of said County, in Civil Case No. 15191, in the Superior Court of San Diego, together with that portion of County Road Survey No. 627 known as Old Mission Gorge Road vacated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that the said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Mission Gorge Road, adjacent and contiguous to Lot 1, all as granted and shown on said map.

BE IT FURTHER RESOLVED, that the said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of sewer facilities and slope rights as granted on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council rejects as a dedication for public street that portion of Lot 1 marked "Reserved for Future Street" as shown on this map, under the provisions of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that that certain easement with the right of ingress and egress for the construction and maintenance of sewer facilities and slope rights, together with certain abutters' rights of access as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated; and said Council has rejected on behalf of the public that portion of Lot 1 marked "Reserved for Future Street" shown on this map within this subdivision, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
