APPROVING MAP OF STANFIELD INDUSTRIAL PARK SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled "STANFIELD INDUSTRIAL PARK Being a subdivision of that portion of the East half of Lot 39 of The Highlands, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 284, filed in the Office of County Recorder of San Diego County, March 16, 1887, lying Southerly of the Southerly Line of Taylor and Sloan Industrial Park Unit No. 1, according to Map thereof No. 6089, filed in the Office of the County Recorder of San Diego County and the Easterly prolongation thereof.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construc-

tion and maintenance of sewer facilities, as granted and shown on said map, and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that that easement with the right of ingress and egress for the construction and maintenance of sewer facilities is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
