BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. The request of this Council on May 18, 1972, that the Planning Commission initiate public hearings on rezoning from R-3 and CN Zones to R-3, R-2A, R-2 and R-1-5 Zones, or any combination thereof, on Lots 2 and 3, Torrey Pines Beach Subdivision; Parcel A, Parcel Map No. 331; Parcel A, Parcel Map No. 332; Parcel A, Parcel Map No. 363; Parcels A, B, C, and D, Parcel Map No. 732; and a portion of Section 23, T14S, R4W, SBBM, is hereby withdrawn.

2. The Planning Commission is hereby directed to initiate public hearings on rezoning, from R-3 and CN Zones to specifically the R-2 Zone, Lots 2 and 3, Torrey Pines Beach Subdivision; Parcel A, Parcel Map No. 331; Parcel A, Parcel Map No. 332; Parcel A, Parcel Map No. 363; Parcel A, B, C, and D, Parcel Map No. 732; and a portion of Section 23, T14S, R4W, SBBM.
