That the Mayor and the City Clerk of said City, be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, the form of which is on file in the office of the City Clerk 740136, conveying to the City of La Mesa, a municipal corporation, a portion of Lot 120 of La Mesa Colony, as more particularly described in said form of grant deed.
- 2. That no broker's commission shall be paid by City on the herein described sale.
- 3. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director of said City for further handling.
