That the City Auditor and Comptroller is hereby authorized to transfer \$6,000 from the Unallocated Reserve Fund (5330) to Parks and Public Buildings Department, solely and exclusively for the purpose of providing funds for the purpose of installing an irrigation system and tree farm on Fiesta Island in Mission Bay Park.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces the necessary work for the installation of an irrigation system and tree farm described above, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City forces more economically than if let by contract.
