
BE IT RESOLVED, by the Council of The City of San Diego as follows:

The request of the subdivider of SAN DIEGO CENTER UNIT NOS. 1 and 2, by Rick Engineering Company, to suspend the operation of Section 102.0221, paragraph 7, as applied to said subdivision is hereby granted in the manner set forth below:

1. A future cable pole may be located at the north-westerly corner of Lot 1 in Unit No. 1.
2. The 12KV facilities on approximately the westerly 1000 feet of said Lot 1 to remain aboveground until Highland Drive, shown on the tentative map, is dedicated to serve the area northwest of Unit No. 1.
3. The 12KV facilities to be installed aboveground on the northerly property line of Lot 2, Unit No. 2, easterly of San Andres Drive, shall be removed when the area immediately east of said Lot 2 is subdivided and the underground facilities in Via de la Valle are extended easterly.
