BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Triangle Steel & Supply Co. 2. Western Metal Supply Co. 3. Wilson F. Clark Co., Div. of American Wholesale Hdwe. are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of HARDWARE AND FASTENERS as may be required for the period of one year beginning July 1, 1972 through June 30, 1973, per prices on file in the Purchasing Department, as follows:

1. Triangle Steel & Supply Co. for Section I; terms 2% 30 days, plus sales tax; prices are firm;
2. Western Metal Supply Co. for Sections II, III and IV; terms 2% 10 days, plus sales tax, subject to price escalation not to exceed 10% of bid price, and;
3. Wilson F. Clark Co., Div. of American Wholesale Hdwe. for Section V; terms 2% 30 days, plus sales tax, subject to price escalation not to exceed 10% of bid price.
