That the offer of International Business Machines is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of 500,000 ORIGINAL UTILITY BILL at a cost of \$7.47 per M; 60,000 FIRST OVERDUE BILL at \$7.41 per M and 30,000 SECOND OVERDUE BILL at \$7.41 per M, plus a set-up charge of \$197.50 for a total cost of \$4,599.40; terms net 30 days, plus sales tax.
