

RESOLUTION NO. 205766 JUN 8 1972

APPROVING MAP OF HAZARD'S CORNER SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled "HAZARD'S CORNER Being a subdivision of a portion of Lot 3 of the partition of portions of Pueblo Lots 1173 and 1174, in the City of San Diego, County of San Diego, State of California, according to Licensed Surveyor's Map thereof No. 170, filed in the Office of County Recorder of San Diego County, May 2, 1913.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of sewer facilities, as granted and shown on said map, and subject to the conditions as set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that

said Council has approved said subdivision map and that that certain easement with the right of ingress and egress for the construction and maintenance of sewer facilities as granted and shown on this map within this subdivision is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
